# **INTRODUCTION**

As most, if not all, of the recipients of this book know, Susan lost a 2-year battle with cancer in July of 2017. Our family and friends all suffered a great loss. I lost my wife and best friend, and there is a large hole in my life.

She was first diagnosed with an auto-immune disease in the fall of 2014. A year later, she was diagnosed with cancer. Her strong spirit and chemotherapy treatment from the Knight Cancer Institute here in Portland helped make her final two years on this earth as good as any could have hoped. She never lost her spirit or her smile and did not show to others her increasing fatigue and pain. That was the way she was.

It has been a very difficult time for the family without her. She was our guiding light, the glue that kept us together, and the one who always worked to keep us united as a family.

During the Christmas holidays of 2017, she would have been writing letters, sending cards, and e-mailing many friends, as well as entertaining and putting together very happy holidays for all of us. But she is no longer here to do this, so we have compiled the contents of this book to honor her, and remind everyone how creative and humorous she was over the years in writing "Christmas Letters".

For the first 30 years of our marriage, she sent out what I describe as wonderful, but "normal", Christmas letters and cards. But she decided in 2000 to begin a series of Christmas Letters she titled: "Life with Father Wreck", taking liberty with the spelling of our last name, but pronounced the same. She often wanted to add the comment: "Life in a Dysfunctional Family", much to the dismay of her mom and mine, amongst many others.....like Woody, Katie and me. But this was her way of using her humor and facetiousness to entertain people. She never considered us dysfunctional, just normal, and wanted to bring out both the positive and negative aspects of our behavior during the year. She particularly delighted in exaggeration and being (seemingly) "tough" on us, but we always knew that she did it with love for us, and we never lost our love for her.

This book is a compilation of those Christmas Letters. Many have read some or all over the years. We wanted you to enjoy hearing her "voice" again. It is lengthy, so we do not expect anyone to read it avidly or even completely. We are just happy to pull the letters together in one place as a tribute to her writing....and deep love for all of us and all of you.

We've included some pictures that show her over the years at some very happy times in her life. We hope these bring a smile and fond memories.

Editor's note: Over the years, many people commented that these letters were written by me, Father Wreck, since they were so sarcastic. That is not true: she wrote them all. She asked for my input at times, accepted some of my punctuation and grammar suggestions, but rejected every one of my suggestions about "content". Regrettably, although there may be some exaggerations about my antics, she knew me well and always seemed capable of remembering my buffoonery.



We were married in 1971 shortly after she graduated.






And then Katie ("Katherine") in 1985

### Christmas 2000

This is a last-ditch effort to save collapsing marriage, on rocky ground since remodel groundbreaking. Tries to impress Susan by telling contractor to shape up or ship out. **March** – Escape Oregon rain and remodel dust for spring training baseball trip to Phoenix with Woody's baseball team. Katie thrilled to go, as all older guys are "hot". Woody more

**April** – Easter Bunny attempts delivery of eggs but fails due to mudslide crossing driveway. Contractor assures us that landscaping design is working; just need to be patient 'til job finished. As requested, Susan developed a punch list: Item #1 - punch contractor.

**May** – Susan runs away from home. Goes to Italy with sister, Leecy. Jim now in big trouble as will have to spend quality time with his own mother for Mother's Day. Tries to get Woody & Katie to intervene on his behalf. They tell him in no uncertain terms that since their mother is nowhere to be found, therefore have no responsibilities for this holiday.

**June** – Susan and Katie decide they need a personal trainer to shape them up for swim season. This a totally ludicrous endeavor from start as Susan would certainly not be caught dead in the suit with a little skirt she bought to hide hanging flesh. Cost of trainer and fitness club membership: approx. \$500. Amortized cost spent in training: \$175.50 per hour. Number of calories burned off from improved training regimen: Katie: 25,889; Susan: 376.

**July** – Woody, Katie and Susan take trip back East to check out colleges. Woody has expanded his criteria for selecting a university: in addition to snowboarding, must include gorgeous girls, and exciting living arrangements. Accordingly, McGill in Montreal scored high on his list. He was most impressed, however, to discover that the University of Vermont actually has a fraternity housed in a barn. Katie definitely ruled out Colgate when she heard that students had to plan bus trips to the mall in

Syracuse one hour away. Jim stayed home to earn money to pay for trip, looming college tuition bills and Katie's wardrobe necessities.


**August** - Since family was functioning as such a high level, determined that could share some of familial bliss with a new member. He felt this would certainly be a challenge for his masculinity, but he was up for it. Katie and Woody all for this idea as figured would give Susan someone else to "mother". Had been over the top trying to make up for MIA Mother's Day. Woody at one point said he refused to come home unless she stopped talking about colleges. Jim saw opportunity for someone new to listen to him as most other family members tuned him out regularly.

**September** – Realization: Jack needed not only to crash house, but also Susan's new BMW. USAA totals car. Jim, in a valiant effort to stave off cancellation by USAA, writes them a letter detailing why they should take pity on him. Presents family members with a copy of this letter and a spreadsheet enumerating the skyrocketing cost of insurance over the past five years: 1996: \$1.567; 1998: \$3,1199; 1999: \$5,613; 2000: \$10,865; 2001 Estimated Cost: \$25,558. Says he needs help. Help, we assure him, is on the way.

**October** – Katie gives up shopping for Halloween. Woody defers buying new snowboard jacket. Susan, despite the fact that for the last year the only thing that has kept her sanity is envisioning, a la Architectural Digest, what the house will look like with new furniture - keeps the coffee table made from Spindleflex, that Jim built the first month of marriage. Jim sees light at end of tunnel. Celebrates by drinking 5<sup>th</sup> of Scotch,

smoking pack of cigarettes and spending most of night lying awake from indigestion. Says he's definitely turning over new leaf before holidays.

**November** - Thanksgiving great with all Jim's cousins here. Mother much better than last year: makes it all the way to dessert course and remembers at least half of relatives. Confuses Jim with Santa Claus but that totally understandable. Jim celebrates by drinking 5<sup>th</sup> of Scotch, smoking undetermined number of cigarettes and spending night in family room sleeping upright in chair.





## Life With Father Wreck Christmas 2002



**January** – 2002 off to great start: throw Recession Party so all Oregon friends in similar financial misery will love company. Luckily, Jim has kept job as Visa bills from exuberant holiday fete come due. Cannot divulge amount of bills due to proper upbringing that doesn't allow talking about anything relevant to real life. Susan and Katie assure Jim that they have listened and learned from his astute financial advice: average markdown for items purchased at after Christmas sales: 73%. Cannot help fact that were so many sales due to looming Depression. Jim refinances house to pay bills. Pays \$7,500 to buy down interest rate, as this lowest interest rates will ever be. Woody returns to UW. All sad to see him go. **February** - Beloved family dog, Boomer, age 14, passes away after a prolonged illness. Jim had issued ultimatum 13 years ago that either the dog had to go or he did. Jim long over the hurt that family voted unanimously in support of dog. Jim holds own private wake in garage in honor of Boomer's passing. Tries to call dogs over as they walk by, but canines clearly leery of smell of scotch. Grieving Jim consoles himself with thought that this is a positive move for his cash flow since cost of end of life care for dog approximately \$1,345. Vet did, however, send nice sympathy card.



**March** – Cannot believe that time has already come to start thinking of colleges for Katie. Wonder if academic record will look good to admissions: number of days missed due to doctor's appointments: 3; catching up on sleep, 8; critical illnesses, 13; family crises, 37. All excuse slips written during school hours while Katie taking break at Boyd's Coffee Shop. Katie feels only schools in a sunny climate (clearly problem with Oregon high

school) will suit her delicate sensibilities, so Susan and Katie make a Spring Break trip to California. Katie loves weather but feels colleges not in close enough proximity to beach. Will consider Arizona schools because, even though not near beach, are near Mexico and therefore in proximity of "hot Hispanic guys". Hire college counselor to find perfect fit school. Jim thinks perfect fit is nunnery, since Katie still madly in love with Freydi, "hot" boyfriend of last year.

**April** – With advent of spring and the annual return of the salmon spawning in the front yard comes renewed sense of purpose for tackling the long -postponed drainage project. Jim determines that all last year's bids from contractors are way out of line for the actual work required. Average contractor bid: \$6,000. Jim's estimated actual cost: \$323. He, Jim, will show them a thing or two by doing all work himself. This has added benefit of getting him out of earshot of Susan. No matter that he doesn't hear any more out of one ear, clearly sees this as means of escape. Jim makes huge discovery that neighbor has 12" pipe emptying water directly onto property line. Requires Susan to document offense in 30, 8x10" glossy photos. Jim revises his cost estimate upward to \$675.

**May** – Since Susan can't seem to get a life, will live vicariously through past lives of dead relatives. Susan, sister Leecy and mother Helen all go on a search for dead ancestors in Virginia. Find old Goodloe homestead still standing and, indeed, still has basement slave jail photographed by ABC news when "Roots" first aired. As a result, conclude that relative depicted in Alex Hailey's story was not in our direct line, thus absolving us of all guilt. Search continuing for ancestors with more politically correct lifestyles and better pedigrees. **June** – Woody survives first year of college. We don't really know this, however, as UW only sends grades to parents if student agrees to share them. Some things we must take on faith. Woody concludes that summer school would be in his best academic interest. Fact that girls subletting rooms in fraternity house only mildly influential in his decision. Woody's summer schedule: sleep 'til 4 p.m., class at 7 p.m., party 'til dawn. Number of hours spent in class, 32, number of hours asleep, presumably in his own room, 900. Plans to find a part time job as ice cream truck driver thwarted when company checked driving record. Also would have to buy ice cream inventory from company and this would pose grave financial risk. Decides to party instead: number of hours, 1,001. Woody's room chosen as "The Ghetto" for fraternity "Round the World" party.

**July** – Life was boring. Jim spends entire month outside, either working on project or smoking cigarettes in garage to relax from taxing physical labor. Susan tries to get Katie to go to a movie with her. Katie asks: doesn't she have any friends of her own? Susan's friend encourages her to consider getting another dog because: think of the prospect of next year with only Jim to keep her company. . . .

**August** – Katie also attends summer school. This we know as we pay her daily. Jim wonders what has gone wrong with family work ethic, as only he seems to have it. Jim gets well deserved break from daily grind when make annual trek to Wisconsin for R & R. Woody and two fraternity brothers drive from Seattle cross country to join us. Itinerary: E-mail parents at 4 a.m. day due to leave Seattle, depart Seattle 5 p.m., arrive in Missoula in time to party at U of Montana with friends. Drive straight on to Minneapolis where sleep in car in parking lot cause too hard to put up tent. Arrive on time in Boulder Junction. Jim is thrilled to have male bonding experience with son and friends. Really wants to be one of the guys. But fish cannot wait until 4 p.m. for breakfast so time lost there. Jim's time spent in fishing boat, 70 hours; time spent with boys, 2 hours; time spent with wife, 0.

**September** – Susan decides to adopt a "if you can't beat them join them" attitude. Figures must have some shared activities with Jim when the nest is empty next year. Attends women's fly fishing school on the Deschutes River. Told this is a very exclusive private fishing resort. Invites friends to join her. Friend packs Lilly Pulitzer outfit to dress for dinner. This big mistake as learn that men do not feel hot water, indoor plumbing, heat or lack of mouse droppings on mattresses essential to quality fly fishing experience. Susan realizes too late likelihood of fly fishing as means to solidify marriage post kids, 0%.



**October** – Jim finally finishes drainage/wall project. Total time spent digging in dirt, 323 hours; cash outlay, \$9,700. Feels macho thrill of using backhoe, and physical exercise benefit totally compensates for fact that arms are now numb 24/7. Jim,

for the second time in same year, refinances house to pay construction costs. Pays \$8,500 to buy down interest rate, as surely this lowest interest rates will ever be.

**November** – Sadly but blessedly, Jim's Mom passes away after battling Alzheimer's disease for many years. Only trouble: we must get her back to Cincinnati for burial. Jim determines that Susan can better handle picking up the cremains. Susan decides that if she married Jim for better or worse, this is the worst. Cremains remain in car as neither Susan nor Jim can figure out a good place to keep them inside. Jim suggests perhaps Mom would like to go to movie with Susan. On trip back to Ohio, Susan manages to get Mom through airport security without getting stopped. Jim pretends he is flying unaccompanied.

**December** – Have survived totally exhausting December ritual of social activities. Number of parties enjoyed by wives, 24, number enjoyed by husbands, 0. Wives sure husbands are lying and would really miss parties if didn't have them next year. Jim totally worthless at parties because cannot hear anything anyone says to him, but keeps talking like he knows exactly what they said anyway.

Jim manages to ease his pain by partaking in much yuletide cheer and dressing in ridiculously old Santa suit that someone noted appeared to have marijuana stuck to the sleeve. Number of neighbors' homes broken into by Santa Jim during caroling party, 2; numbers of school aged girls horrified by Santa Jim, 12; number of children now aware that Santa drinks and smokes, 35; number of parties Santa Jim likely to be invited to next year, 0. Maybe, just maybe, he's not so dumb after all.

## Life With Father Wreck Christmas 2003





**January** – Have rechecked calendar for 2003 to see what exciting events occurred in past year. First entry for any activity - social or business, for any member of family - dated January 18. This is pathetic indication that Susan failed to get a life despite declaring this need years ago. Perhaps also a reflection of un-popularity of Jim after Christmas 2002 "Bad Santa" performance. Susan contemplates a life without Jim so that she can once again be invited out socially. Jim tells Susan he feels her new life should be income producing. Susan begins to wonder what planet Jim is living on, as her job skills are circa 1975 when computers were run by key punch cards. Jim suggests perhaps a career in abstinence counseling would utilize the skills she's developed over the past few years. Jim begins project to redo basement though no member of the family ever ventures down to that wetland. Marital bonding suffers accordingly but "Jimmy Fix-It" is happy camper.

**February** – Great news! Katie gets accepted to many colleges. Now must begin arduous task of choosing right school for her. Right school must provide single dorm room, close proximity to quality shopping experiences, hair, tanning and nail salons. Access to tattoo parlor also desirable, just in case Susan changes her mind regarding this form of art. Susan volunteers to visit campuses with Katie, but Katie feels input of Freydi – hot Hispanic boyfriend of past two years – much more important. Jim completes basement project: now have great exercise room though no member of the family ever chooses to burn off accumulated fat rolls by using costly equipment installed by Jim.

March – Rains return - a rite of spring in Oregon. Jim discovers that forgot to put water barrier in rock wall constructed last summer. Small waterfalls emerging through rocks and

channeling new gullies toward house foundation. Jim rationalizes that rebuilding the wall provides a great opportunity to add stone pathway through the bog now created next to house. Additional \$6,503 needed for repairs and pathway. Katie back ends a pickup truck with the Landrover when brakes "freeze up". Both Susan and Katie remark that the "little red brake light on the dash kept coming on" during the preceding few weeks. Katie refuses to drive car again because now feels Landrover "has issues". Susan trades cars with Katie. Jim has major issues with Katie and Susan's reasoning abilities.

**April** – Heard from Woody for the first time in 2003. Good to know he's so happy up in Seattle. Tried to point out that would be nice if he would answer his cell phone from time to time, as we sometimes wonder what's up with him. Also, mentioned the fact that year-to-date Susan has forwarded 563 humorous messages and Jim 444 pornographic emails none of which Woody felt warranted reply. Enquired about his grades and got the response that they were "way better" than he had expected.

**May** – The week before Susan's 54<sup>th</sup> birthday, the neighborhood women hold a "Princess Party" as a school fundraiser where the ladies come dressed as princesses. Susan in distraught mental state as can no longer visualize herself as princess material. This could be due to the added 40 lbs. that living the stressful life with Jim has forced upon her. Jim, in an attempt to be sensitive, suggests that perhaps she could go as the Queen Mom. Susan and Jim celebrate 32<sup>nd</sup> anniversary only after Jim atones for total lack of understanding of the female psyche.

**June** – Are truly exuberant as watch Katie handed her high school diploma. She looks lovely as she walks across the stage. Cost of new shoes \$150, cost of hair coloring, ditto. Additional expenses associated with graduation: nails, \$50; eyebrow

waxing, \$35; series of tanning appointments, \$130; new dress which was only worn for pre-graduation dinner and then covered by gown, \$200. Outfit for post grad all night party (\$100 admission) of undetermined cost as we never got to see what she wore as were not allowed to volunteer to chaperone. Katie pleased that she's been educated at a liberal establishment, is a down to earth person, who doesn't have a lot of material needs. The University of Arizona will suit her perfectly she determines after orientation in Tucson. Have wonderful trip to Maryland to attend wedding and visit old friends. Jim embarrasses himself/Susan with lengthy roast at reception dinner after multiple cocktails. Friends think speech is hysterical; Susan becomes hysterical.

July – Woody on remote island in Alaska for six-week archaeological dig through UW. In this way he deftly avoids getting a summer job that pays money, while dig requires full tuition and board for Summer Quarter. Total communication from Woody during sojourn: one pre-addressed (by Susan), stamped postcard. It read "Sorry I didn't call. Having a blast. Only one bear so far." Jim also remote as works on project to design and build custom window well covers in effort to keep unused exercise equipment dry. Susan remarks that it looks like "you built the window well covers yourself". Jim takes this as Timing of project coincides with arrival of complement. Susan's Mom and sister Leecy. Katie, desiring of a more functional family structure, decides to travel to Maryland to meet her birth mother. Luckily for Katie, the birth mom also kept in touch with Katie's' birth father (twice divorced) who "really loosened up after a few beers", has a hot tub that fits 12, and a motorcycle, wants her to come back and "hang out" and be part of her life. Jim refuses to discuss this with Susan but secretly ponders, as he sips scotch in the garage, if his 1991 Volvo, complete with tape deck, offers Katie the same appeal. After a few scotches Jim determines that if this guy wants to be part of Katie's life he can start by paying college tuition. Jim feels better after the 15<sup>th</sup> scotch.

August - Woody returns from Alaska in one piece, with 2 unused postcards and huge quantities of soggy, moldy belongings. Total showers taken during six weeks: 0. Total haircut and/or shaving: 0. Total alcohol consumed: 0. Makes up for alcohol withdrawal by having wild orgy upon return to civilization of Kodiak. Susan proud when sees photos from the party that Woody has matching Jim Beam bottle and t-shirt, since fashion lectures clearly have taken root. Woody determines to continue to grow hair 'til can sport a mullet and goatee. Susan rationalizes that Ben Affleck also has facial hair now, so that Woody is clearly fashion forward. Jim, Susan and Katie spend five days setting up Katie's Arizona dorm room to her exacting specifications. Time used shopping at Target and Home Depot: 9 hours. Hours spent by Jim hooking up computer and building desk: 14. Hours consumed by Katie at pool trying to de-stress from ordeal with parents: 17. Jim and Susan return home August 25 and send out invitations for their "Empty Nest" party scheduled for Sept. 13.

**September** – Five days after leaving Katie in Tucson, Katie decides to surprise Jim for his birthday and "mails" herself home for the Labor Day weekend. Tells Jim she so appreciates all he does for her. Jim totally falls for this line of flattery. Time Katie spends with Dad during 3-day visit: 2 hours. Time spent with Freydi: 2 days, 22 hours. After a record short college career of 8 days, Katie determines that Tucson is way too hot, way too far away and calls the U of Oregon. Miraculously they re-accept her and even give her a single dorm room. Katie returns to Portland

in time to attend the "Empty Nest" party with Jim and Susan before heading to Eugene.



**October** – Jim and Susan make trek to northern Wisconsin and luck out with great friends and great weather. Jim and friend Greg each claim to catch a 45-inch Musky, but no pictures, despite availability of digital camera in boat. "Fish were too big, and their teeth were too sharp to get them in the boat". After Wisconsin, Susan continues on to Georgia for a vacation with Mom while Jim returns to Portland. Upon arriving in Atlanta, Susan discovers that Jim took her bag to Portland and sent her to Atlanta with his bag full of dirty fishing clothes. Tears followed by anger followed by profanity. This costs Jim big bucks, as he has to concede his error and agrees to pay for Susan's shopping. Fortunately, however, interest rates did not go up as Jim predicted last year so could afford shopping by refinancing. Mortgage broker rewards best customer, Jim, with two courtside tickets to Blazer game. Cost of tickets in points and fees paid over three refinancings: \$12,009 each. This great deal, though, as Blazers so popular.



**November** – Susan, really scared after suitcase episode that Jim is losing it mentally, decides that duplicate bridge will help her keep her mind sharp, so she can stay alert and nurse Jim in his dotage. Spends numerous days learning the new "weak two" system, attending Bridge Camp at the coast. This great escape from marital bonding and partially empty nest – Katie in residence most weekends so that romance can blossom, and Woody entertains girlfriend, Sarah, for Thanksgiving. Jim clearly jealous that Katie and Woody seem to be getting "lucky" while Jim just getting decrepit. Jim declares romance for those under 30 immoral. This clear indication of Alzheimer's onset, as not at all what he told Susan at Northwestern.



**December** –Bad Santa Jim on parole at all Christmas parties this season. Behavior was exemplary as all, or most neighbors, will

attest. Number of Diet Cokes drunk by Jim: 195, number of scotches, 162, number of cigarettes smoked, undetermined, number of husbands disgusted that Jim is no longer setting the scale for "D-group" antics, 56. Is there a glimmer of hope for 2004? Will Jim continue with his self-improvement program? Will Susan realize that bridge is neither a life nor even a good way to lose weight? Will Susan and Jim ever have an empty nest? Will Woody ever call? Only time will tell . . .

**January** - New Year's resolutions: never again stay with whole family in Oregon for whole Christmas vacation. Never again believe Jim when he says: "trust me". Jim will give up alcohol for entire month of January. Jim panics when learns month of January actually has five weekends. Searches Internet to download fine points of Oregon's medical marijuana law. Woody, returning to UW, rear-ends an RV when braking on icy I-5. Repair bill, \$800. Jim suggests irresponsibility involved. Katie rear-ended on snowy street. No real damage, but Jim suggests irresponsibility involved. Jim's pool equipment freezes again for second year in row due to lack of his winter maintenance. Cost: \$1,100. Jim suggests act of God. **February** – Jim avoids working on Susan's list of fix-it projects for fifth consecutive year. Instead feels time is better spent playing solitaire on the computer while simultaneously watching TV. Multitasking demonstration of Jim's continued mental acuity which is indeed better after liver recovery regimen. However, Alzheimer's an ever-present danger as most nights Jim cannot seem to remember that Susan lives in the house with him. Witness the fact that no clear memory exists of what we did on Valentine's Day. Could that have been wildly passionate night? Jim fails to notice when Susan flies to Florida to celebrate Mom's 85<sup>th</sup> birthday with siblings. Mom seems glad that no spouses are included as says it's the best birthday ever.

Jim March - Return of Spring stirs Jim from hibernation. awakes to find Oregon environment is in grave peril from uncontrolled growth of evil plant, ivy. 

2008 - The Lost Year - Recap: Jim avoids divorce; Katie and Freydi marry December 28, 2008!!!












What Susan learns from DVD: Jim suffering from male menopause – should get testosterone checked immediately.







Rendezvous with Bill, Paige and Joanna in Chapel Hill and old college friends, the Muffleman's while staying at Inn at Warner Hall. Jim and David prove to wives that have not matured a bit since graduation 45 year ago by drinking all wine in Inn's cellar.

**October** – Happy occasion of wedding of Ty Reynolds good reason to return to Georgia where Jim and Susan lived when Jim in Navy. Have great time visiting Athens again with Sapera's, staying with college friends, the Bertelson's, seeing Susan's Henry and Duncan relations and planting a tree in Valdosta in honor of steel magnolia mother, Helen Duncan Barnett and aunt, Sarah Garbutt Duncan. Sue, Carey, Laurie and Leecy attend planting ceremony and cousins have delightful day exploring haunts of ancestors and eating biscuits and other scrumptious southern delicacies they remember from childhood.





- We made our annual vacation in northern Wisconsin in all three years.






































Antonio Joseph Gomez born in January of 2017. A truly wonderful day for all.

Susan Barnett Rech passed away on July 28<sup>th.</sup> after a two-year battle with cancer. She had family at her side and was finally out of pain and is now at peace.

Susan was born on May 9, 1949 in Milwaukee, Wisconsin. She was blessed with loving parents, Joe and Helen Barnett, and three siblings, Bob, Leecy and Bill. She attended Lake Bluff Elementary School and Shorewood High School in the Milwaukee area. She earned an undergraduate degree at Northwestern University and a master's degree at the University of Georgia.

After marrying Jim Rech in 1971, she pursued many lines of work before her children arrived. In Newport Rhode Island, she worked at an antique shop.
